Showmanship and Barrel classes will be the tie-breakers for all awards. 	<p>HIGH POINT AWARDS</p> <ol style="list-style-type: none"> 1. Awards are a one horse/one rider combination per division. 2. Separate horses may be used for English, Western and Gymkhana. 3. Any Horse/Rider combination in a W/T class may not compete in other events within the same division. 4. Any rider in a W/T class also competing in non W/T classes on a different horse is not eligible for any W/T awards. 	<p>SHOW RULES</p> <ol style="list-style-type: none"> 1. 4-H Code of Conduct will be enforced at all times. 2. 4-H rules apply - age is as of Jan 1 and participants must be 8 as of January 1, 2019. 3. Helmets must be worn by all participants under 19 whenever mounted. All other equipment to be in accordance with the Colorado 2018 4-H rule book. 4. In Western classes, W/T riders may use 2 hands with proper western snaffle bit and western reins. Other riders wishing to use 2 hands must present Level 1/novice status at registration.
